### COST


- \$100 for one advanced wrestler

- \$200 for a family (must be siblings)

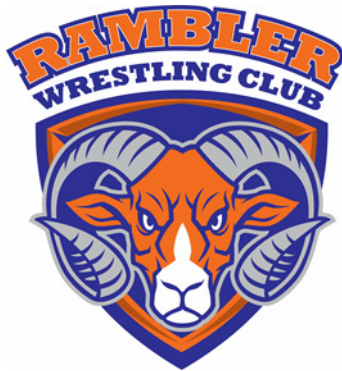
### PRACTICE SCHEDULE

Starting on November 1, all novice (1st & 2nd year) practices will be Tuesday and Thursday from 5:30-6:30pm. All advanced practices will be Monday-Thursday 6:30-8:00pm.

- Q.** What is the benefit of registering with RWC?  
**A.** Your registration covers 365 days of registration with RWC. This includes all practices for the regular wrestling season, spring, and summer practices. All paid members also receive two t-shirts and a pair of shorts. RWC also pays for one novice tournament or one open tournament.

**A.** No, the club will lend singlets to all the RWC wrestlers.

### CODE OF CONDUCT

Achieving a high level of sportsmanship in our sport starts with YOU! Participating in the sport of wrestling is a privilege, not a right. As with all privileges, there comes responsibility. One of your responsibilities as a representative of our community, our wrestling family, and our sport, is to conduct yourself in a way that reflects positively on yourself, your coaches, your teammates, your family and the sport of wrestling in general. The Rambler Wrestling Club is a community-based volunteer parent run organization. It is important that all wrestlers, parents and coaches pledge to adhere to the following:

- 1) I will show good sportsmanship at all times. Swearing, throwing headgear, kicking, hitting, talking back and other forms of un-sportsman like behaviors will not be tolerated.
- 2) I will respect and not criticize my teammates, coaches or others.
- 3) I will control my temper.
- 4) I will respect the opposing team and shake hands at the beginning and conclusion of each dual/match or where required.
- 5) I will not taunt or yell at opposing players or teams.
- 6) I will respect referees and not openly criticize them. I will remember that they are in control of the match/dual and that they are human and will make mistakes. The referees will have the last word, even if it results in me being asked to leave the event.
- 7) I will show respect to all equipment, supplies and facilities (home and away).
- 8) I will not make any alterations to club-issued apparel or equipment that must be returned and I understand that I will be held financially responsible for any damages to club issued items.
- 9) I will strive to have fun and help ensure that my teammates have a fun wrestling experience as well.
- 10) I will play hard and fair at all times.
- 11) I will do my best to be on time and attend practice on a regular basis.

I have read and understand the Rambler Wrestling Club CODE OF CONDUCT. I understand that any violation of this code may result in disciplinary action being taken against me up to and including suspension or removal from club/team/events without a refund. Concerns in any of these areas should be brought to the attention of an adult, a coach or a board member immediately. The club reserves the right to deal with situations on an individual basis and handle as they see fit.
